TRU MBA \$3,000 Entrance Award

A limited number of awards of \$3,000 each are available for domestic applicants to the TRU MBA degree program.

Applicants must

- › show exceptional promise for success in and after their MBA studies
- › be a Canadian citizen or permanent resident
- › be enrolled in a full-time (100%) TRU MBA course load

The award will be applied as a tuition reduction of \$2,000 at the start of classes in the Fall 2012 semester. The remaining \$1,000 will be applied as a tuition reduction for the Winter 2013 semester.

If a recipient accepts an MBA Entrance Award but fails to register at TRU by the last day for payment of fees for the appropriate semester, the award will be cancelled. The Financial Aid and Awards Office will advise the student in writing to this effect.
- › Should a TRU Entrance Award recipient withdraw during the first or subsequent semesters of the period of study for which the award is granted, the balance of the award will be cancelled.
