Notes to the FTE Enrolment Report
Year ended March 31, 2008

1. Basis of Actual FTE Calculation:

A revised FTE Audited Enrolment Reporting Manual was issued in September 2005 by the British Columbia Ministry of Advanced Education ("the Ministry"). Following Ministry directives, this manual was used to calculate student FTE Enrolment in this report. In accordance with Ministry communications, course extensions are counted for FTE reporting purposes where a fee has been charged for the extension.

2. Industrial Training Authority Enrolments:

This report includes enrolments for Entry Level Trades and Apprenticeship training funded by the Authority for which enrolment targets have not been provided.

3. International Enrolments:

This report includes enrolments for International Students. These enrolments, calculated based on course credits or class hours, are shown separately as they are not counted towards the target established by the Ministry.
