APEC 2660-3 Resource Development on First Nation Lands

Calendar Description

In this course students will examine several different facets of resource development on First Nation lands. The course will summarize the history of First Nation traditional resource governance and management. It will explain the utilization of the Institutional Analysis and Development (IAD) framework to evaluate the success of community-based natural resource management, both historically and in the future. It will also examine the legal framework, environmental review process and fiscal and economic impacts associated with existing or proposed resource projects within First Nation territories. Lastly, the course will focus on how First Nations can successfully negotiate agreements and mediate disputes to maximize the benefit of these agreements for their communities. Topics include history of First Nation resource management and Ostrom IAD framework; Aboriginal title and resource development; fiscal and economic impacts of resource projects; environmental review of resource projects; and resource project interest-based negotiation and dispute resolution. The course incorporates examples and case studies of actual First Nation resource agreements and disputes. It culminates in a First Nation resource project negotiation simulation and role play.

Educational Objectives/Outcomes

Upon completion of this course, students will be able to:

- 1. Understand the importance of jurisdiction and how to convey its importance to resource project stakeholders
- 2. Identify important historical aspects of traditional resources practices of Indigenous people in Canada
- 3. Identify the linkage between the Ostrom Framework and traditional resource practices of Indigenous people
- 4. Explain the Ostrom Framework's applicability to future resources management and First Nation jurisdiction
- 5. Describe the First Nation legal (Aboriginal title) and policy environment for resource development in territories.
- 6. Identify unique First Nation environmental interests and processes.
- 7. Describe the lifecycles of different resource projects
- 8. Recognize the links between natural resources and economic development
- 9. Explain the difference between fiscal and economic impacts from resource development.
- 10. Describe the economic and fiscal impacts in the different phases of mining, pipeline and forestry projects.

11. Explain the general methodology for fiscal and economic assessments

- 12. Identify and articulate the interests of various stakeholders by resource project
- 13. Analyze interest based solutions in resource development agreements
- 14. Identify possible opportunities to increase fiscal and economic benefits and manage environmental risks
- 15. Assess resource based negotiation outcomes

Assignment 1 – Advancing Resources Management Jurisdiction – Develop a briefing note using historical sources to identify traditional resource management practices and relate this practice to the Ostrom Framework best practices.

Assignment 2 – "Ask a lawyer" project – Develop specific questions and rationale associated with different types of projects.

Assignment 3 – Fiscal and Economic Benefits – Develop a briefing note comparing fiscal and economic benefits from project assessment for different jurisdictions and citizens and make strategic recommendations to Chief and Council.

Assignment 4 – Analyzing and Negotiating Potential Project Benefits – Select one of three hypothetical projects for a hypothetical First Nation and explain differences between fiscal and economic benefits associated with selected project, the elements of a potential agreement and recommend the order of priority and reason for each element.

Assignment 5 – Two-part Negotiation Role-play – Based on a proposed resource project to be developed within a territory claimed by two First Nations. Students will have to outline a plan to deal with the other stakeholder First Nation, the resource project proponent and applicable governments. Students will also write a summary that provides a description of the process, results and lessons from the simulation. Roles will also be provided by the course instructor.
