BUSINESS ARISING FROM MINUTES

ESAC proposal to the TRU Human Resources Department to have sustainability as the theme for the upcoming February 22 TRU In-

Service Day. Karl mentioned that CUPE should know about this idea. Jim said that Larry Phillips was looking into this issue. On motion duly made by Tom, seconded by Crystal, and approved by all other members it was resolved to approve the following idea: to form a subcommittee to help with the details surrounding the in-service day. The following agreed to sit on this committee: Michael, Tom, Karl, James, Wayne, and Jim. Some ideas that were put forward to discuss include:

- focus on what we do at TRU that can transfer over to what we do in our homes, and vice a versa;
- have some sort of sustainability innovation contest during the day and offer a great prize at the end for the best idea;
- discuss the new TRU development The Reach in so far as it touches on sustainability issues;
- other themes for the day to consider include transportation, food, recycling, and composting.
- Other big issues to consider: who can be approached as a keynote speaker(s), and what is the budget for the event.

 Susan reported that she send a request to Brenda Smith, co-chair organizing committee of the February Teaching Practices Colloquium at TRU in regards to having 'sustainability in curriculum' as a topic of discussion for next year's agenda. Susan will report back on this at the next ESAC meeting.

- Susan is now requesting ideas from ESAC members for keynote speakers for this event. In regards to speakers, there was some enthusiasm for the idea of doing several smaller TED talk-style presentations, compared to one longer one.
- Susan also talked about how she would like to expand this subcommittee to include TRU members from all corners of TRU who are not on the ESAC. Scott will investigate whether there are any procedural reasons why this cannot happen. Forming an Academic Subcommittee to the ESAC and report back at the next meeting.

Regarding Susan's idea of attending one of ASSHE's workshops on the 'nuts and bolts' of getting sustainability content into the curriculum (there is one Jan 5/6 2017 in Atlanta, Georgia), Jim thought it made more sense to bring an expert presenter here to TRU so that everyone else interested in the topic could participate. He will investigate this while at the upcoming ASSHE conference in Baltimore.

Regarding the motion from the last ESAC meeting, that Susan should bring a revised presentation she did for ESAC members (at the June meeting) to the TRU Senate in order to find out their views on embedding sustainability in the curriculum, Scott said that this decision has been passed on to the Teaching and Learning Committee who have asked her to make a presentation to them at their Nov 4th meeting.

Updates to new ESAC Sharepoint site - James reported that he has **James** not had time to do anything, but will pursue this for the next meeting.

<u>Vision for EAC</u>– Wayne will lead a discussion on next steps at the Wayne December 7 meeting.

Discuss joining Canadian Universities Environmental Network -

Tom reported that the Provost has approved this. He will follow up (regarding next steps) for the next meeting.

Administration of the Sustainability Grant Fund. Crystal had some concerns regarding a fair and transparent process in regards to the awarding of funds for research projects. She will check with how other universities administer similar grant funds.

Waste/composting food from retailers on campus – Amie began the discussion on this topic and the following came out of it:

- station at the city of Kamloops water treatment plant downtown, along with a in-vessel composting machine (who will manage this needs to be worked out);
- in order to cut back on the amount of edible food being thrown out, perhaps a sliding price scale - based on time of day - could be implemented around campus (i.e. use basic economic principles of supply and demand: pizza is full price from noon to three; then drops 20% from 3 to 4, and another 20% from four onwards, etc.).
- Jim mentioned that the Sustainability Office is working on a Sustainability Procurement Policy, and that the time has come to bring in an expert to refine it.

Jim also mentioned that he will ask Glenn Read, from TRU Ancillary Services, and Jessica Papineau, from Aramark, to come Jim to an ESAC meeting to discuss the issues of food waste and food options at either the November 2 or December 7 meeting.
