

### HOW DOES COPYRIGHT WORK IN CANADA?

© Protects original works:

- books
- sound/ video recordings
- dramatic, musical and artistic
- photographs & other printed or digital material
- Only copyright owner can
  produce, reproduce, perform,
  publish, adapt, translate and
  telecommunicate the work.





# PERMISSION TO COPY – 5 STEPS

- 1. Is the work protected by copyright?
- 2. Is a substantial portion of the work used?
- 3. Does permission (license) already exist?
- 4. Is copying permitted under:
  - Copyright Act / Education exception?
  - Fair Dealing?
- 5. Do I need to obtain copyright clearance?

### TRU FAIR DEALING POLICY – SHORT EXCERPTS

- C Up to 10% of a "work" or one chapter.
- C An article from a periodical or newspaper.
- C An entry from an encyclopedia, annotated bibliography, dictionary (reference work).
- C An artistic work from a work containing other artistic works.
- C A single poem or musical score from a work containing other poems or musical scores.

### **OBTAINING PERMISSIONS AND LICENSES**

Does your intended use of a copyright-protected work fall outside the terms of a site license, Fair Dealing or another exception to copyright?

© You'll need documented permission (a license) to use it.



### PROTECT YOURSELF AND THE UNIVERSITY

- © Record your use of third-party materials or have the Copyright Office do this for you.
- © Get a license if you are using more than a short excerpt of unlicensed content and your use is not covered by an education exception.
- © Cite/credit ...however, acknowledgement is not a substitute for copyright clearance.
- © When in doubt, ask permission of copyright owner or ask the Copyright Office to help.



# PRINTED COURSEPACKS

- © All third-party materials need clearance.
- © For clearance please provide a detailed list of any new and or existing 3rd party materials you wish to reproduce.
  (see Required Information)
- © A copy of the full PDF is needed by our department for final clearance or to cross reference with your list of requested materials.

**Required Information:** 

- © Course acronym code
- © Author or creator
- © Title of journal article, chapter/ page number(s), or DIRECT URL (not a search engine result)
- © Name of journal, textbook or website source





- © All third-party materials need clearance.
- © Send the Copyright Office a list of materials you wish to use in an email with all of the required information.

If possible,

© Scan third-party materials and send us a pdf copy for our records.

- © If fees apply for obtaining a license to use third-party materials, approval to purchase the license is required by the faculty member.
