The new plan is to get this issue on the agenda for both the Senate meeting October 26 and the Board of Governors meeting December 4. Also, the two new ESAC students representatives, Thamindu and Christin, will ask TRUSU to sign on.

5b. Regarding the matter of discussions with TRUSU about setting waste parameters so that vendors at the Back-To-School BBQ (TRU's largest event) and other similar events won't bring so many single-use items that need disposing of, James reported that he sent a second email to Nathan Lane but has had no response. He will follow up once it's likely that there will be such an event post-Covid. This item is tabled until that time.

5c. James reported that the registration site is open so that all current TRU students, staff and faculty members can attendfor free--the October 20-22 virtual Global Conference on Sustainability in Higher Education, put on annually by AASHE (Association for the Advancement of Sustainability in Higher Education).
