Dear EPC Members:

As a follow up to the EPC meeting of October 1<sup>st</sup>, I am forwarding information on the English admission requirement update that was addressed under 5 (a) New Business.

In an effort to bring consistency and clarity to English/Communications admission requirements we would suggest you consider bringing forward to your Faculty Council's the following updates:

- For Programs where English 1100 remains a required course we would recommend the existing admissions language be updated to read:
  - o English 12/English 12 First Peoples with a minimum of 73% (or equivalent).
- For Programs where a Communications course is utilized rather than an English 1100 course, and where this Communications course is void of a pre-requisite, we would recommend the existing admissions language be updated to read:
  - o English 12/English 12 First Peoples with a minimum of 67% (or equivalent).
- For Programs where there are no required English or Communications courses within the Program, we would recommend the admissions language be updated to read:
  - o English 12/English 12 First Peoples (or equivalent)

The "equivalent" will be the determined by the prerequisites for the required courses in the programs. This will help address changes to prerequisites that are currently tied to admission requirements.

Currently, these updates are in effect under a provisional approval granted by the Provost's Office. In order to make the permanent updates, faculties are asked to make this change to affected programs by submitting program changes through CurricUNET. The timeline for minor program change approval is approximately 6 months, therefore please submit the program changes by no later than January 1, 2015 to EPC so they can meet Senate approval timelines.

## **Bean Counting:**

- 3% higher enrolments overall for this semester
- We have a balanced budget for the end of 2<sup>nd</sup> quarter
- Fiscally we are ok, but we have to constantly be doing recruiting types of things

### **Problem solving**

- Exam scheduling: some issues in areas were flagged by faculty to the Dean, and the faculty followed up with the Dean's approval and issues were resolved; unfortunately apparently other problems were created
- There is a new exam schedule posted please look at it

### Planning

- There is a new budget methodology coming forward, and it is hard to predict what we are getting year to year, but the Dean (with the help of the Chairs) delivers a service plan, cost of running all different programs
- What I have to do is justify all of the positions in that service plan and show work plans that shows our efficiencies and how we are maximizing our people, space
- Big item coming is the replacement of equipment, departments need to do comprehensive inventories and build it in to their budget

- Yes, Economics has put forward a Masters of Science (so has Nursing)

# **REPORTS**

i) Senators' Report from September 22, 2014 Senate Meeting (By: Cynthia Ross Friedman and David Sheets)

## Items of significance for Science Faculty:

 Notice of Motion - ED 5-0 (Student) Academic Integrity. Changes to Policy ED 5-0 are proposed. Many of these changes deal with the newer climate of online cheating, and also very clearly spells out examples. The changes seem very good, and the student Senators are in favour of the proposed changes.

- 2) **Presidential Review.** A survey will be coming to faculty and other stakeholders. Gordon Randolph has been appointed by the Steering Committee as the only faculty member (and faculty Senator) to the review committee. If anyone knows who Gordon Randolph is, please let us know.
- 3) **Master of Science in Economic Sustainable Management (SoBE)**. A course-base Master's degree with a thesis option has passed Senate. It now goes to the Degree Quality Assessment Board (DQAB). Economists do publish in science journals and use the scientific method, and so this degree makes sense for those students wanting a strong economics degree. The external reviews are very favourable.

#### Faculty Council Terms of Reference

As requested by faculty council last year the terms of reference have been rewritten by the steering committee to encompass the principles of collegial governance. The proposed changes are highlighted in the attached terms of reference.

#### Faculty of Science representative on ACTAC

Three faculty members have expressed interest in serving on the Academic Computing Technology Advisory Committee (ACTAC) so an electronic vote should be held. Mindy Marshal, John Church and Faheem Ahmed are the 3 candidates.

#### ii) h) Faculty of Science Educational Programs Committee (By: Eric Littley) Minutes of September 22, 2014

<u>Biol 1110/1210 Course Changes</u>: These were considered together, as the changes requested were identical. Ron Smith provided a brief summary of the change, which was to allow students re-taking the courses to be exempted from re-taking the labs provided they had achieved at least a 70% grade in the lab within the previous 2 years. The change was approved.

<u>Math 1300</u>: The only change requested for this course was to add an exclusion that students could not get credit for both Math 1300 and Math 2120, which has been de facto practice for years in any case. The change was approved.

<u>MDLB 1191</u>: Dave Sheets provided us with a summary of the intent of this new course for the distance Med Lab program. The change was approved.

Brewery Maintenance Certificate and Brewery Technologist Certificate: Ron Smith explained that these two new programs were subsets of the previously approved Brewing program, and would allow qualified students to come for a shorter period of time for an upgrading of their credentials. This would help bolster numbers in the program, and provide a useful service to the industry. After some discussion of process, the committee approved both programs to move forward.

Proposed Changes to Policy ED 16-0: Eric Littley presented a summary of the proposed changes as they affect the Faculty of Science programs (appended below). After a spirited discussion, there was a very strong feeling among committee members that many of the proposed changes were a significant move in the wrong direction that would serve to dilute our degrees and our reputation. Eric Littley will produce a summary document for the Dean, and will attend the open meeting on this issue on September 24.

Proposed Changes to the BSc in new policy ED 16-0

These proposals signify a significant watering down of the academic standards in TRU degrees, as well as loss of options for students. While we would not be required to revise our current degrees, it is possible that when we choose to update those degrees, there will be pressure to reduce the expensive upper level courses and replace them with lower level courses taught by cheap sessionals in massive classes with low per-student costs. As a new university, TRU cannot afford to do anything that harms the reputation of our degrees, just as we are beginning to establish that reputation. I can see no possible benefit for academic programs in this proposal, and no rationale for the university to propose this, other than misguided cost cutting.

### ii) i) Masters of Environmental Science Program – Information for Faculty Council Meeting Oct 16, 2014

Wendy Gardner is the new chair/coordinator for the Masters of Environmental Science Program and Marcy Desrosiers is acting as a part-time administrative assistant (0.25).

As of September 2014 the Masters of Environmental Science has a new program in place. The changes drop the course load slightly from the previous program but increase the thesis credits and add in a required dissemination/outreach component. The new program is outlined below.

For the fall 2014 start we have 6 new students (5 domestic, 1 international) and for the winter 2015 start 5 students (all international) have been accepted. We have a total of 33 continuing students with 17 of these being in their first 2 years of the program.
