Purpose of the Challenge: To enable the industry, as well as observers, to view the level of skills taught within the secondary education system.

Skills & Knowledge to be tested: The level of this competition will allow the young stylists to demonstrate their technical skills and creative ability in the following tests:

- Ladies Fashion Day Style with Color Enhancement
- Men's Current Fashion Hairstyle Current with Color Enhancement

NOTE: No written test will be administered. The theoretical knowledge will be relevant in the performance of the practical tests.

Safety Instructions: Competitors must demonstrate aptitude in safety awareness.

Equipment / Tools / Materials Supplied by Contestant:

- 10 Towels
- Chemical Colors
- Bowl and Brush (or applicator bottle)
- Color Remover
- Styling Products
- Shoulders and Drapery (or clothing and jewelry not mandatory)
- Makeup for touch up only (make up for manneguin pre-done)
- All Styling/Working Tools (Clips, Cutting Tools & Razors, Blow Dryer, Curling & Flat Irons)
- Mannequin stand (holder)

Clothing Requirements: Clothing should be clean and comfortable as would be worn by staff working in a modern hair salon as well as any protective clothing as needed. Closed toe shoes are mandatory.

Supplied by the Technical Committee

- 1 female mannequin
- 1 male mannequin
- mirror

Judging / Distribution of Marks All judging will be performed according to the 30 Point International System. Demerits may be given for any rule infractions. Any communication between audience and competitor during contest times may be seen as coaching and could result in demerits. No head sets, walkmans or portable CD players allowed. No technical support such as formulas, pictures, drawings, notes, etc.



TEST #1 - LADIES FASHION DAY STYLE WITH COLOR ENHANCEMENT

Time limit: 1.5 hours

Hair Style: A day style will be performed. The hairstyle, in texture and form, is to be that seen in the latest fashion magazines. It must present a feminine impression.

Products and Tools: All styling tools and products are allowed. All hairpieces, wigs, extensions, and bobby pins are forbidden

Color: The mannequin may be pre-colored using one or more coloring techniques. No color enhancement may be done during the competition. The choice of color is free. No color sprays, gels or mousses are allowed.

Haircut: The mannequin may be pre-cut but a **minimum** of 1 inch **MUST** be cut during the competition. The style is of the competitors own choice. The finished cut must not be more than 4" in the nape.

Blow-Dry: The competitors must perform a blow-dry and style, on wet hair.

Set-up and Draping: (Optional) Jewelry and clothing may be added. Touch up of makeup is allowed.

Assessment: Overall impression 10 points: Color enhancement 10 points: Cut and style 10 points

TEST # 2 - MEN'S HAIRSTYLING WITH COLOR ENHANCEMENT

Time limit: 1.5 hours

Hairstyle: The hairstyle, in texture and form, is to be those seen in the latest fashion magazines. It must present a masculine impression.

Products and Tools: All styling products and tools are permitted.

Color: Mannequin will be pre-colored to competitor's choice of color using one or more coloring techniques. Colors must be a harmonious graduation of two or more colors and must represent a masculine impression. No color enhancement may be done during the competition. No colored sprays, gels or mousse allowed. The beard may be colored and pre-cut (but will not be marked)

Haircut: The mannequin may be pre-cut but a **MINIMUM** of 1 inch **MUST** be cut during the competition. All cutting tools are allowed. Finished cut be not be more than 4" in the nape. No restrictions on haircutting techniques.

Set-up & Draping: (Optional) Jewelry and clothing may be added. Touch up of makeup is allowed.

Assessment: Overall impression 10 points: Color enhancement 10 points: Cut & Style 10 points
